Accomplished health professional with broad experience in public health, private practice, and academia. Receive continuous support from state representatives, Pennsylvania Senator, medical community, and college administration for innovative health programs and processes. **Doggedly pursue new insight from around the world** to apply to University Park programs.

- **Awarded \$3.2M in federal government grants over a 14-year period** to implement The Male Pregnancy Prevention Program ("Wise Teens") throughout 28 schools in the Pike County and Pike Independent school systems, and to open The Male Clinic—the first and *only* sexual health clinic for men in the state.
- Supervised 192 professors and residents as Director of Fellowship Programs. Also supervised and trained 21 nurses, clerks, and medical students as Clinic Director; and 6 health educators as Director of the Male Pregnancy Prevention Program.
- **Provided dental care to 300+ Pike County children** through prevention program in conjunction with the University of Pennsylvania.
- **Visited France, Poland, and the Czech Republic** to compare the U.S. health care system with those of other countries, and to discuss low teen pregnancy rates. **Travel of own volition and expenses to improve the quality of life for Pike County residents.**
- **Invited to speak locally and nationally for 14+ years** on the topic of male pregnancy prevention programs; recruited to serve as Visiting Professor for the Children's Hospital of Philadelphia to train residents.
- **Received recognition letter from the President of the American Academy of Pediatrics** for creating a software program to enhance management processes by documenting patient medical history, physical exam, and treatment.

The Male Pregnancy Prevention Program, Pike County Health Department (1998-2014)

1 of 26 programs in the U.S. funded by the federal government

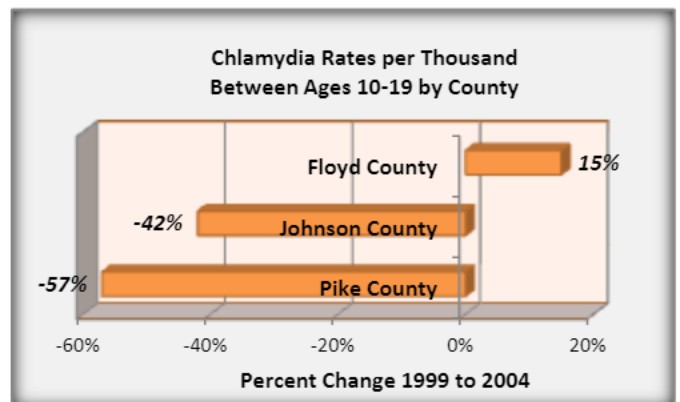
Developed innovative programs to educate students on sex education / abstinence to combat high teen pregnancy rates in Pike County, Pennsylvania (a rate significantly higher than the rest of the nation) and sexually transmitted diseases. Educated 2,800 students annually in the Pike County and Pike Independent school systems.

- Competed with ~120 applicants for grants, successfully receiving a \$150K grant for 14 consecutive years from the Office of Population Affairs.
- **Birth rates decreased 35.2% in Pike County within five years.**
- **Birth rates decreased 23% with program held after graduation.**

The Male Clinic, Pike County Health Department (2001-2012)

Opened the first and only sexual-health clinic for men in the state of Pennsylvania, with only a handful operating in the country.

- Obtained a competitive grant of \$75K from the Office of Population Affairs for 11 consecutive years.
- Provided free clinical services for 600+ male patients annually between the ages of 16-28.
- **Program reached 8K+ boys in 14-years**, imparting values such as self-esteem, goal setting, life skills, education, and *the right choices.*
- **Program contributed to reduction in the incidences of Chlamydia by 57% among teenage males and females.**

Challenge:

Dr. Bradley, a 70-year-old doctor, contacted me with a “rush” turnaround because he had seen a posting for what he considered his “DREAM JOB” as Public Health Director. At this point in his life, it wasn’t about money.

A day or two later, FED EX arrived with 100+ pages of copied articles, certificates, performance endorsements, diplomas, etc.

Action:

This résumé needed to tell a story about a gentleman who dedicated his life to “making a difference” to those living in some level of poverty, where pregnancy rates were significantly higher than the rest of the nation.

I sifted through all of the information, highlighting and circling transferable skills and quantifiable achievements. His achievements through program implementation and the opening of a Male Clinic were best showcased in two graphs. After 18 straight hours of analyzing and writing, I had the information needed to present this successful doctor and amazing humanitarian — spending his own money to travel abroad to compare health care systems to improve the one in his county.

Page 1 tells the story ... and page 2 consists of black and white facts that cannot be disputed as far as work history, education, memberships, travel, and a publication.

Results:

Less than 3 weeks after the résumé completion, I received an email from Dr. “Bradley” stating that he “had the best résumé and he was the winner”!
